We are very fortunate to have such a dedicated team who work very hard to make this happen. Effective July 1 of each year water rates are increased by an amount equal to the percentage increase, if any, in the consumer price index [All Urban Consumers (CPI-U), U.S. City Average, All Items (1982-84=100)] between April of the then-current year and April of the then-previous year. In no event shall the increase in any particular year exceed six percent. **Https://www.bls.gov/cpi/latest-numbers.htm**

The purpose of these fees is to generate sufficient revenues to pay for the administration, operation and maintenance of the District's water distribution system, to provide for repairs and depreciation of the water system, to provide for unforeseen emergencies, and to pay for other lawful obligations and expenses of the District.
