<u>Introductions</u>

Director Todd Goodman was appointed to fill the vacant position on the Board at our February meeting, Todd; has a long history in our community. Please help us welcome him to the Board.

Backup Operator

Tim Taylor is the GM at Sky View County Water District in Paynes Creek and is our backup operator, for the requirements of 7-daysaweek water monitoring. So the GM is able to get a little time off. Also during the water leaks Tim helped with looking for leaks and with digging out main valves so we could isolate sections of town.

Winter Leaks

We have had several leaks this year, and John has invested many hours in leak detection. The costs incurred due to leaks affect all of us. By state regulations, all water that goes through our system must be treated. When we lost over 312,000 gallons of water due to leaks. Because of the leaks we have to run the filtration and replace filters that costs the District and our customers to treat all those gallons of water.

IMPORTANT

WINTERIZING Your House

We strongly encourage all households have they own shutoff valve for use through-

out the year, and to request that John Frehse shut off the curb-stop valve for you at the meter when you drain and winterize your house. Following this suggested procedure protects you from costs accrued due to leaks on your end of the water meter.

This must be done through

John: customers should never shut District valves. This procedure also helps us to locate possible leaks, because we will know which homes are shut off. Because of associated costs in work hours and overtime in looking for leaks, the Board voted to approve a policy stating that the customer will not be charged for the first hour of leak detection, after which a leak detection charge will be added to the bill if a leak is found at your property.

Arrange to check or have someone else check your cabin periodically during the winter months, especially after a cold freeze. The quicker a problem is found, the sooner it can be resolved, that will save the home owner money. The Board and John Frehse appreciate the cooperation and assistance of the community in helping to locate leaks this winter.

FY 2017-18 Audit

GM/Secretary Position

At the request of our General Manager, the Board is restructuring the General Manager/Secretary position to hire a Secretary, enabling our GM to focus on plant operations. Look for a job posting to this end soon!

Tank Maintenance

In December, 2017, the Board entered into a contract with Superior Tank Solutions (STS) of Cucamonga, California for long-term maintenance of our 324,000gallon storage tank. The contract effectively transfers technical and legal responsibility for the tank's maintenance and protection to STS. Through this contract, we are able to spread the costs of recoating the tank's interior over many years, while STS will perform all regular inspections, maintenance, repairs, and upgrades required by Cal-OSHA.

They will be using divers this year to inspect the tank, also

they will be working on safety requirements that were implemented by Cal-OSHA. In 2021-22 FY is when our 324,000 gallon tank will be re coated inside and out. Look for updates in the future.

Community Use of Facility

The Board recently approved use of the meeting room at the District Office for free community events in the interest of contributing to our community and is in the process of incorporating this into our policies and procedures. This involves an application and Board or employee sponsorship.
